**COMMUNITY USE OF SRHS FACILITIES**

The user shall comply with the following terms and conditions as well as any other terms which may be specified by the unit administrator and attached as an addendum to the request:

1. Request form shall be submitted to the Executive Secretary at least (10) days prior to use date.
2. Smoking, illegal drugs or alcoholic beverages are not allowed. No refreshments are to be served or sold on school grounds or in the buildings except in the appropriate facilities and with the prior approval on the unit administrator.
3. The user shall provide needed custodial services, cafeteria employees, and/or other employees during each period of use and to clean up and replace facilities after each activity.
4. Administrators or caretakers (custodians, security, AV Technician, etc.) are to have access to all facilities at any and all times. Premises are to be vacated and lights are to be out at the specified time on the request form.
5. No apparatus, furniture or equipment may be moved into SRHS property unless permission is granted by the unit administrator/superintendent. All school property utilized in connection with the use shall be accounted for by the user and shall be left in as good condition as received. User agrees that it will pay for any wear, tear, breakage or damages to facility or its contents. Extra property is to be removed from the premises no later than twenty-four (24) hours after the scheduled activity unless permission has been granted by the Principal/Superintendent.
6. Any advertising for the promotion of this program, such as newspaper releases, posters, tickets and handbills, must indicate the sponsoring agent/organization.
7. If SRHS Administration should decide that use of the facility is not in the best interests of the Education Division, the use of the facility shall be cancelled on the date/s specified in the request form by notifying the user in the following manner:
  - by telephone
  - by messenger
  - by letter to address as given on Request Form
8. The user agrees in indemnify and hold harmless the SRHS from any claims or loss by the reason if of the user's use or misuse of the premises and from any claim or loss by reason of any accident or damage to any person or property happening on said premises in connection with the user.
9. The user agrees that SRHS is not responsible for any property left by the user or brought to the premises by the user, or by any other persons or entity in connection with the use of SRHS facilities. The user agrees that SRHS shall have no liability for destruction, theft, vandalism, or other loss or damage to any such property.
10. The user affirms that no event will be held for the purpose of advancing any theory subversive to the constitutions or laws of the SRPMIC, state of Arizona or the United States, or the purpose of advocating social or political change by violence.
11. It is understood that the Governing Board or designee reserves the right to make additional conditions and stipulations and that these conditions and stipulations will be attached to the Request.
